Eligibility Criteria for BCSA Study Centre

The BCSA Study Centre should satisfy the following criteria.

- Should be in business (IT related or otherwise) or should be a professional with the required entrepreneurial acumen.
- Should be willing to invest required amount of money in setting up a centre with proper infrastructure and main power.
- Should have commitment for providing quality training to students.
- Should be willing to be a part of the BCSA team in accepting the terms and condition and procedures as laid down by BCSA.

Profitability of Operations

The granting of study centre status would be possible after careful study of the market potential, number of students graduation form the relevant streams etc.

The specifics in terms of operational economics will be discussed in person with each of the study centres.

The study centres are required to make a study of the Engineering Colleges,

Polytechnics and science college and other institutes of the area by way to the number of students passing out each year.

Expectation From the Affiliated Study Centre
